Combined, these studies have the potential to transform current donor selection practices and reduce the risk of leukemia relapse in patients.

Project 1 was dedicated to clinical trials of anti-B cell therapy that address the unmet need during three phases of cGVHD: pre-clinical presentation, initial therapy and late stage disease. Project 2 was dedicated to the identification and testing of new drug and peptide therapies of cGVHD in a robust mouse model of cGVHD associated with fibrosis. Project 3 was dedicated to understanding the immunologic effects of B cell-directed therapies and potential mechanisms by which these new treatments alter B cell function *in vivo*.

In this Program, we focus on the critical questions that plague the field of cGVHD. We address shortcomings in our understanding of the pathogenesis of human cGVHD and our ability to prioritize the next generation of therapeutic strategies by defining the immune networks that characterize patients who develop cGVHD and interrogate the mechanisms of both success and failure of cGVHD treatment regimens. We explore the unique metabolic demands in cGVHD pathogenesis and lung injury repair and focus therapeutics on the most severe manifestation of cGVHD, Bronchiolitis Obliterans Syndrome (BOS). We employ novel organoid cultures and immunogenomics to pinpoint the cellular and antigenic targets of BOS.

Clinical Innovations

Myelodysplastic Syndrome (1999-)

I remain dedicated to understanding the optimal timing of transplantation for this variable group of hematologic disorders. The role of transplantation has become more complicated with the approval of non-transplant therapies to treat this disorder. I currently am leading the national trial to demonstrate superiority of allogeneic stem cell transplantation in comparison to non-transplant therapies. This trial will include outcome measures such as cost-effectiveness and quality of life. Additionally, I have been involved in several national efforts to address the Centers for Medicare Services Coverage with Evidence Determination program.

Novel Approaches in Prevention of Acute Graft-vs.-Host Disease (2000-)

Over the past 20 years I have led the development of sirolimus in graft-versus-host disease (GVHD) prophylaxis. As a result of these studies, sirolimus has become a standard of care at the DFCI and nationwide, considered equivalent to the standard of tacrolimus and methotrexate. This drug is now used broadly across multiple transplant scenarios and conditions, including myeloablative and reduced intensity transplantation, umbilical cord blood transplantation and in transplantation with renal insufficiency. Multiple centers, both in North America and Europe use this agent as part of their standard regimens.

B Cells in Chronic GVHD (2011)

B cells may be implicated in the pathophysiology of chronic graft-versus-host disease (GVHD), as evidenced by antibody production against sex-mismatched, Y chromosome-encoded minor HLA antigens in association with chronic GVHD. I designed a phase 1/2 study of anti-B-cell therapy with rituximab in steroid-refractory chronic GVHD. In this study, we concluded that specific anti-B-cell therapy with rituximab may be beneficial for patients with steroid refractory chronic GVHD. This prospective trial has led to the widespread acceptance of this agent as a therapy in steroid-refractory chronic GVHD. Focusing on B cell signaling, I and my team developed a multicenter,

open-label clinical trial that evaluated the safety and efficacy of the BTK-inhibitor, ibrutinib, in patients with active chronic GVHD with inadequate response to corticosteroid-containing therapies. Ibrutinib resulted in clinically meaningful responses with acceptable safety in patients with greater than or equal 1 prior treatment for cGVHD. Based on these results, ibrutinib was approved by the FDA for treatment of adult patients with cGVHD after failure of 1 or more lines of systemic therapy. I continue to lead innovative trials of novel agents in chronic GVHD prevention and therapy, and I am currently leading the only prospective randomized trial designed to evaluate the role of B cell depletion as a preventative strategy for chronic GVHD.

Umbilical Cord Blood Transplantation and Modulation (2005-)

I have been the leader of the umbilical cord blood transplantation program at DFCI since its inception, developing new conditioning and GVHD prevention regimens. I previously led an industry-academic partnership examining the role of pre-transplantation modulation of umbilical cord blood products with the prostaglandin derivative, 16,16 dimethyl prostaglandin E2. Three clinical trials in different settings have been completed and I remain in charge of our cord blood research program at DFCI.

Stem Cell Transplant Survivorship (2010-)

Over the last few years I have assembled a new clinic at the DFCI, focusing on the long-term survivorship needs of stem cell transplantation clinic. The bi-monthly clinic is staffed by subspecialists in oral medicine, dermatology, ophthalmology as well as nutritionists, exercise physiologists and psychosocial providers.

Report of Technological and Other Scientific Innovations

Workload Assessment Tool for Research Protocols (WARP) (2017-)

The tool is a set of formulas and nomograms that can be used to objectively measure and forecast the workload of an individual or multiple clinical trial protocols. This system of workload management is an improvement over the OPAL scoring system by tailoring the scoring to the individual team using it and implementing the formulas into a comprehensive team dashboard showcasing current workloads, future projections, accrual completion goals, and distribution of effort across research areas. The tool can be used for budgetary projections as well.

Narrative Report

I am an Institute Physician in Medical Oncology at DFCI, an Associate Physician in Medical Oncology at BWH and a Professor of Medicine at HMS. My Area of Excellence is Clinical Expertise and Innovation. I have Significant Supporting Activities of Investigation and Administration and Institutional Service.

Clinical Expertise and Innovation: I am a stem cell transplantation physician, devoting approximately half of my time to the care of patients with hematological malignancies undergoing allogeneic hematopoietic stem cell transplantation (HSCT). I attend on the inpatient stem cell transplantation service at BWH 6 weeks per year and in the ambulatory Stem Cell Transplantation clinic 4 half-day sessions per week, the Stem Cell Transplantation Survivorship clinic 1 half-day per month and the Cutaneous Oncology clinic 1 half-day per month, all at DFCI.

My expertise in the prevention and treatment of acute and chronic graft-vs.-host-disease (GVHD) stems from years in clinical practice as well as the development of innovative drug-based approaches to the prevention and treatment of acute and chronic GVHD. Acute GVHD occurs in 35-55% of patients undergoing HSCT and is one of the most important causes of morbidity and mortality after HSCT. Over the past few years, I have developed a strategy to prevent acute GVHD using the novel immunosuppressant, sirolimus. This compound has now been tested in several clinical scenarios, including related and unrelated donor HSCT, and umbilical cord blood transplantation. As a result of these phase II investigations, sirolimus was tested in a randomized, phase III multicenter trial conducted by the Blood and Marrow Transplant Clinical Trials Network where I served as the Principal Investigator. The results of this trial confirm that the combination of sirolimus and tacrolimus is an acceptable standard for GVHD prevention. This regimen has now become the standard of care at several centers both nationally and internationally. In addition to the prevention of acute GVHD, I am also

developing novel therapeutics for the prevention and treatment of chronic GVHD. Chronic GVHD is the most important cause of late morbidity and mortality after allogeneic stem cell transplantation and occurs in up to 60% of HSCT survivors. I conducted the largest prospective trial of the monoclonal anti-B cell antibody, rituximab in chronic GVHD, and this compound is now considered standard-of-care therapy. Based on our work on B cells in chronic GVHD, we performed a trial of ibrutinib as therapy for chronic GVHD, leading to the FDA approval of this agent for this indication. Notably, this was the first drug approval for the therapy of GVHD granted by the FDA. Most recently, I have begun a clinical trial using a novel anti-B cell agent for prevention of chronic GVHD. This work is supported by a P01 award from the NIH, and I serve as the overall Principal Investigator. This grant incorporates elements of basic biology, murine modeling and clinical trials at several US centers. I am simultaneously testing several other interesting compounds for the treatment of established, steroid-resistant acute and chronic GVHD based on biological pathways and mechanisms discovered as part of our P01 grant.

Significant Supporting Activity: Investigation: I have spent 2 decades investigating the optimal role and timing of allogeneic stem cell transplantation for the Myelodysplastic syndromes. I have led a number of studies in this field, including a seminal decision analysis that was the first to demonstrate the utility of allogeneic transplantation for younger individuals. I currently am leading the national trial to demonstrate superiority of allogeneic stem cell transplantation in comparison to non-transplant therapies. This trial will include outcome measures such as cost-effectiveness and quality of life. Additionally, I have been involved in several national efforts to address the Centers for Medicare Services Coverage with Evidence Determination program. In addition to work in MDS, I perform studies in umbilical cord blood transplantation and lead the DF/HCC cord blood program.

Significant Supporting Activity: Administration and Institutional Service: My administrative responsibilities now include the overall supervision of the Stem Cell Transplantation Program as Medical Director. I have managed our Division's Research portfolio, established a successful Advanced Transplantation Fellowship Program and am responsible for starting our successful Survivorship Program as well. I have served as the Treasurer of the American Society for Blood and Marrow Transplantation for the past 6 years and serve on a number of committees for the Center for International Blood and Marrow Transplantation Research.

Teaching: I have several teaching responsibilities in addition to teaching and supervising fellows in hematology/oncology at the DFCI. I teach clinical trial design and methodology at an annual research training course for fellows and junior faculty in transplantation, sponsored by the American Society for Transplantation and Cellular Therapy. I established an advanced Fellowship Program in Stem Cell Transplantation which has been accredited by Partners, and we currently have accepted our 6th fellow into this program.
